Sir,

I am to refer to the subject and reference cited above and to inform you that KVS Hqrs has sought a report on the arrangements made for starting of new KV under civil sector in Rewa / Sagar w.e.f. 1.4.2004. A copy of the office order No. F. 1-29(1)/2003-KVS (Acad.1) dated 6.2.2004 of KVS Hqrs New Delhi conveying the approval of the Chairman KVS for opening of new KV at Sagar / Rewa is enclosed for information.

2. In this connection, you are requested to take an appointment with the Collector / Chairman VMC KV so that the Education Officer who would be visiting your KV during this week will discuss the same with him and submit a report to the undersigned for onward transmission to KVS Hqrs. The following are some of the points to be discussed with the Collector:

- Provision of land on lease or permanent transfer measuring at least 15 acres in the city
- Temporary accommodation with all facilities like water, power, etc. for starting the KV w.e.f. 1.4.2004 till the permanent building is constructed

3. You may identify a suitable location in the prime locality for starting the new KV before meeting the Collector and request him for allocation of the same in favour of Kendriya Vidyalaya Sangathan. You may also handover this letter to the Collector through the Education Officer.
