The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of affiliation for secondary classes:

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
4. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

6. It will continue to pay an Annual Fee of Rs. 3000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of **Secretary, CBSE, payable at Delhi**. This may be complied in future.

7. **Annual fee has been received upto 31/03/2018.**

8. **Special conditions to be complied within three months:-**


- i) The school is required to submit the copy of annual fee receipt issued by the CBSE RO, Ajmer for the period of 01/04/2010 to 31/03/2016 of Rs.15,000/- /-(i.e. annual fee for the session 2010-12 of Rs.3,000/- @ Rs.1,500/- per annum and 2012-2016 of Rs.12,000/- @ Rs.3,000/- per annum).
- ii) The school is required to submit the latest copy of Health & Sanitary Certificate issued by the Competent Authority of the State.
